### Chairman's Foreword

This Annual Reports shows but a snapshot of the work Parish Council during the past year but we hope that within the following pages you will gain an oversight of what we have done and the year ahead.

The workload for Parish and Town Councils wherever they are increases significantly year on year, with the many changes which are taking place both nationally and locally including the many consultation documents from Government and local authorities requiring our comments. As mentioned in our Report of 2012, the development of HS2 continues to take a vast amount of our time about which we attempt to keep you up to date. There has been delay in the timescale for HS2 since Royal Assent but it is now noticeably moving forward.

However, it is with grave concern that we learnt earlier this year of the two-year delay in the diversion of the A4010 Risborough road. The Parish Council and the local community had been assured before and at the Parliamentary Select Committee stage, that this would be completed prior to commencement of the rail structure. Any delay will have a significant adverse effect on the road structure around Aylesbury town, our primary school, the village centre and the Parish as a whole. The Parish Council has approached HS2 protesting at this significant change and will keep in touch with the contractors to ensure that you are kept up to date by public meetings and through the pages of the Parish Magazine.

During the past year planning consents have been granted for large scale developments in villages around Aylesbury town and there are more in the pipeline for Stoke Mandeville. Whilst recognising the need for additional housing we feel that this should be done in a planned and considered way taking account of the area including green space. All infrastructure should be in place before building starts. Serious problems have already been experienced due to a lack of site and traffic management on a development along a main road in the village leading to Aylesbury town which is also a "blue light" route.

The Parish Council opposed the closure of the Sports and Social Club in Lower Road which it had listed as an Asset of Community Value. Should this site be sold the Community would be given six months in which to make a bid to purchase which would give an excellent opportunity for a community leisure facility and sports ground. This has already been achieved in other areas by sports clubs and other organisations working together to raise funds. It is the last piece of green space in the area and we firmly believe that it should remain as a site for leisure and sporting facilities.

Former Parish Councils have been seeking for many years to provide a new burial ground which has now become urgent. Land has been located in Marsh Lane which will take eight hundred plots. Work needs to be done to upgrade the site and funds sought to enable work to go ahead.

Despite all of this, the 'day job' for Councillors continues, looking after the daily needs of the Parish such as changes to street lights, new bus shelters and litter bins, the maintenance and cutting of roadside grass verges and hedges, maintenance as well as safety of the playing field and other assets.

This year the Parish Council received the Silver Award in the National Association of Local Councils Quality Award Scheme, which has been designed to celebrate the very best of local Councils and those at the cutting edge of the sector.

During the year our Clerk of five years Sarah Copley moved on and our current Clerk, Tony Skeggs is now based in the Parish Office at the Community Centre. A Parish Support Officer will be joining Tony later this year due to our increased workload.

Next year brings Parish and Town Council elections which is a four-yearly cycle. Through this Report I encourage local people with an interest in their community to consider becoming a Parish Councillor. As Parish Councils are a tier of Government there is a national criteria which has to be met but no special skills are required and the work is varied, interesting and satisfying. Details will be widely advertised by Aylesbury Vale District Council in April next year. For those interested in becoming a Parish Councillor further information can be obtained from our Clerk.

In conclusion, my thanks to fellow Councillors for their hard work and commitment during this busy and eventful year; to the Trustees of the Stoke Mandeville and Other Parishes Charity for the financial support received; Stoke Mandeville Village Community Association for their hard work in maintaining the Centre and for their co-operation; to our District and County Councillors for their interest in our work and attending our meetings and to Councillor Steve Atkinson who resigned in March due to moving away from the area.

#### The Parish of Stoke Mandeville

The parish of Stoke Mandeville was established in 1894 and covers approximately 1,600 acres and has a population of about 6,000. For administrative purposes, it is divided into 4 electoral wards: Stoke Mandeville Village, Stoke Grange, Stoke Leys and Hawkslade. Though the parish is mainly agricultural in nature, there are a number of small commercial and industrial establishments such as village shops, the Weston Park and Triangle Park Business Parks, the Belmore Centre on Lower Road and the Goat Farm Centre at Old Risborough Road with a number of small outlets offering a variety of goods and crafts in a rural setting. Stoke Mandeville is also fortunate in having its own primary school, two Community Centres, playing field, post office and railway station providing good connectivity by rail and bus.

### What is the function of a parish council?

A Parish Council is a Local Authority comprising councillors who are elected for a four year period after which they can be re elected.

Parish councils have powers to provide and maintain certain facilities within their parish. In Stoke Mandeville, these include the Queen Elizabeth II playing field and leisure facilities, Community Centres at Eskdale Road and Hawkslade, allotments and burial ground. We also maintain our bus shelters, public seats, litter bins, dog waste bins, the ruins and site of the Old Church off Risborough Road and some street lighting. Stoke Mandeville Parish Council has also entered into a devolved services contract with Bucks County Council for the cutting of the highway grass verges, weed control and other maintenance work previously undertaken by the Highways Authority.

Parish councils play a vital part in obtaining and representing local views on various issues. As a Statutory Body they are consulted by other public authorities such as district councils, county councils, health authorities and government departments on specific issues affecting their parish. They have a legal right to be consulted on planning applications and can be consulted on schools and highway matters. The Parish Council works within a Committee Structure with meetings of the full Council being held on the third Tuesday of the month at 7.30pm supported by a number of Committees being Governance and Resources, Planning, Leisure and Environment. All meetings are open to public and press and further details can be found on Notice Boards around the Parish and on our website.

Each parish council has to appoint a Clerk / Responsible Finance Officer to deal with correspondence, general administration and finance as well as running the Council's affairs.

### Council Members

Stoke Mandeville Parish Council has a total of twelve Councillors, elected or co-opted to the Parish Council, although there is currently one vacancy for Stoke Grange. If you are interested in becoming a councillor please contact the Chairman or Clerk.

The Council meets, usually on the third Tuesday of every month except August. Details of the meetings are on the notice boards within the Parish and can be obtained from the Clerk on request.

## Review of 2017-18 Street Lights

The Parish Council owns and maintains the street lights in Stoke Mandeville Village and Stoke Leys wards. The Council has a rolling programme in place to upgrade all its street lights to LED lamps. The next phase to be upgraded during 2018 includes Plested Court, Station Road, Carters Ride and Brudenell Drive. The rest of Stoke Leys including Winterton Drive will be done at the same time.

If you notice any issues with street lights please report to the Clerk, giving the street light number and street location. Residents in Hawkslade and Stoke Grange should contact Transport for Bucks to report any street lights out in their road – 0845 230 2882.

### **Committee Reports**

#### **Environment Committee**

#### **Members**

The Environment Committee has successfully faced and addressed a number of challenges in 2017/18. Top of the list has been the shortage of remaining space at the burial ground at Swallow Lane and the management of the site. After searching for many years the Council has agreed on the use of disused allotment land in Marsh Lane, which required the permission of the Secretary of State on change of classification.

Aylesbury Town Council has continued to carry out grass cutting and maintenance services across most Parish wards this year on a contractual basis on behalf of the Council. Again their work has been complimented by residents who praise its frequency and quality. More street lights will be replaced with LED units during 2019 and 2020, whilst broken or dysfunctional lamps are replaced with LED units as a matter of course. The financial savings to the Council in revenue costs is considerable.

The Committee has continuously monitored and drawn attention to potholes on our local roads, which have been particularly noticeable of late. The Council continues to check the styles and footpaths across local fields as well as monitoring car parking, which has caused difficulty on roads near to Stoke Mandeville Hospital and also near the station. The amount of litter along local roads especially those leading away from the village centre continues and I would like to take this opportunity of reminding the public of the need to keep the village tidy, especially as the Council has entered Best Kept Village Competition once again.

### Bucks Sports and Social Club, Lower Road

In July 2017 the Parish Council and local community became aware of an imminent decision the County Council was to make about the future of the Buckinghamshire Sports and Social Club on Lower Road. The news article carried by Mix 96 reported that the Council might be closing the Sports and Social Club with almost immediate effect. As soon as the report went public the Parish Council and members of the local community banded together to see if the club and its facilities could be preserved.

The Parish Council had already taken steps in 2015 to retain this precious green space the only remaining space in the area, as an Asset of Community Value, giving the Council or the community an opportunity to bid to buy the facility if it were ever to be disposed. The County Council's decision to close the Lower Road site was successfully challenged and the decision reviewed by the Finance and Resources Select Committee of the County Council, giving club members a chance to build a business case for its future management.

Despite concerted efforts by Parish Councillors and the community, the business plan was rejected by the County Council and the decision to close the facility upheld. This was disappointing, the only ray of light coming from the County Council's agreement for the football clubs to continue using pitches until the end of the 2017/2018 season. The Parish Council continues to press for the retention of this site as publically available green space - a green lung for the Stoke Leys and Hawkslade wards. It will also continue discussing with the County Council so that it can provide further updates to residents and the local community.

### Governance and Finance Committee

Funds remain tight for your Parish Council. The street lights project is ongoing with more work to be done at the end of the financial year 2018/19. We will be approximately half way through the project at that stage.

In addition, 2018 /19 is likely to be the final year of subsidy towards the devolved services for cutting of roadside verges, path clearance, cleaning of roadside signs and weed spraying amongst other things, which we have taken over from the County Council. We are, therefore, planning our finances so that there is not too much of a shock in case no further subsidy is available.

As far as Governance goes, we continue to monitor our policies and procedures including a detailed risk assessment. The effort we make to follow best practice was validated this year when the Parish Council was awarded the Silver Level Quality Council Award. Our driving ambition is to maintain this status offering excellent value for money. The Silver Award means that we remain on the cusp of the lowest third of precepting Councils within Aylesbury Vale, which suggest that we are on the right track.

I offer my thanks to my fellow committee members for their efforts during the year and to our residents as "precept" payers for their support.

#### Leisure Committee

#### **Members**

During the past year a number of tasks have been under consideration by the Committee resulting in:

- Extensive work has been undertaken to clear recurring blockages of the drains at the Community Centre.
- Loose paving and handrails around the Centre have been repaired and repointed.
- Repairs have been made to the patio area and further work is planned.
- Following requests from enthusiastic tennis players the tennis court lines were repainted in the Spring of 2017.
- The Pollyanna Playgroup has recently negotiated with the Council to establish an outside play area at the rear of the Centre in order to comply with Ofsted requirements and to provide a shed for storage of outside materials.
- Continuing on from several popular sessions held last summer, Play Around the Parishes will be returning on two afternoons in August 2018. In the event of wet weather, the sessions will be held in the Main Hall of the Centre.
- The committee received a report of the annual ROSPA inspection and was pleased to learn that no major deficiencies were found. Repairs have been undertaken to minor items identified within the report.

- Major concerns existed due to flooding of the children's playground due to water from the rear of an adjacent field. This has now been addressed by the landowner and work undertaken to resolve the problem.
- This committee continues to meet, once a year with representatives of SMVCA to exchange views and updates in respect of the Community Centre and surrounding area.

### **Planning Committee**

The work of the Planning Committee has intensified during the past year and it now meets on a monthly basis. The number of planning applications received for consideration has increased especially for sites of multiple housing.

The Parish Council does not make decisions on planning applications, which is done by the local planning authority, Aylesbury Vale District Council, but is a consultee and offers comments on applications it receives from the local planning authority. If the comments of the Council are not in accord with the decision of the Planning Case Officer then the application is referred to the appropriate Planning Committee of AVDC for a decision by members within the guidance of the National Policy Planning Framework. Parish Councils and public who have commented on the proposals are able to address the Committee. Attendance at these meetings has become frequent for us. We have opposed a number of applications for sites of multiple units, believing that these are premature, there being no agreed Vale of Aylesbury Local Plan, are speculative, without infrastructure and lead to overcrowding of local facilities such as education, health and community as well as loss of green space and amenity.

The recent development along Lower Road, which is a narrow 'B' arterial road leading into Aylesbury town, has shown the problems, which can arise with bad traffic and site management and the adverse effect this has on road users, residents, local businesses and the community as a whole. The problems are not isolated to Stoke Mandeville but affect all those villages adjacent to Aylesbury. Without "staggering" of development sites at the planning stage and close monitoring of active sites we predict worsening problems. A further two sites along Lower Road already have planning permissions for 242 dwellings and further developments are planned within the Parish of Stoke Mandeville including 1,500 dwellings on the South West of Aylesbury [including Hawkslade], Aylesbury Garden Town and the South East Aylesbury Link Road from the A.41 to Lower Road where it meets the diverted A.4010. It is therefore essential that there is no delay in the construction of this road and that it is in place before work begins on HS2.

The Council is consulted on street names for new developments in its area which during the current year has included that for 190 dwellings [Bloor Homes] and 125 dwellings [Crest Nicholson] both sites being in Lower Road. Street names for a given site have to be within a "theme" which is often difficult as the "theme" cannot include names of those living or any street names already in place in an adjoining parish. After much deliberation we suggested the names of music composers for the Bloor Homes site and those of cities hosting the Paralympic Games for Crest Nicholson site which is adjacent to Stoke Mandeville Hospital and would mark the connection between Stoke Mandeville and the Paralympic Games. The decision rests with the developers, the local planning authority and the developers.

Obtaining planning permission for a second burial ground for the Parish has been an ongoing item of business within our meetings. The Secretary of State has agreed to the re classification of allotment land in Marsh Lane for this purpose following a search over many years for a suitable site without success. However, considerable delay has occurred in the planning process as burial grounds are termed as 'business use' for the purpose of planning. We are also faced with undertaking archaeological trenching due to the possibility of archaeological finds in the area. In the meantime the Parish Council continues to seek grant funding in the sum of about £200,000 to fund the development much needed for our increasing population.

### Neighbourhood Plan

Although not a Committee of the Parish Council, as Neighbourhood Plans are optional and not a legal requirement, the Parish Council has overarching responsibility for the development of the work ensuring that this is brought to fruition by the independent steering group, members of which are from Stoke Mandeville community and includes Parish Councillors.

The draft vision for the Neighbourhood Plan is

Stoke Mandeville will be a community where people want to live, work and play.

The Neighbourhood Plan will guide and shape future development in the parish by:

- Developing a shared vision for Stoke Mandeville
- Choose where new homes, shops, offices and other development should be built
- Identify and protect local green spaces
- Influence what new buildings should look like.

However, it cannot be used to prevent development that is included in the Local Plan but can guide infrastructure and facilities. The Policies of the Local Plan will still apply to a neighbourhood whether there is a Neighbourhood Plan or otherwise.

The Stoke Mandeville Neighbourhood Plan Steering Group has continued its work throughout the year. The original timetable has slipped but the first draft of the Plan is expected to be available within the next two months. The main reason for the delay has been the limited number of volunteers available to

undertake the many tasks necessary in the Plan's preparation and further volunteers are required to help with development of the Policies based on the research already carried out or in the writing of the Plan.

As set out in last year's Annual Report responses to the parish-wide questionnaire were analysed and used to inform the Evidence Papers which in turn allow the Vision and the Objectives to be "fine-tuned" to reflect the opinions of the residents. The Analysis Report is available on the Neighbourhood Plan website at <a href="www.smnp.org.uk">www.smnp.org.uk</a> and the results were also shared with residents at the Community Consultation Feedback Event held at the Community Centre on 19<sup>th</sup> November 2017. This was very well attended and the feedback and comments that were collected have also been added to the Evidence Papers. The next step is to draw out the Policies that will frame the first draft of the Plan itself. There will be further opportunities for consultation to ensure that the Neighbourhood Plan properly and accurately represents the view of the community before the Plan is submitted for independent examination and ultimately, a referendum to determine its adoption or otherwise.

### Membership of external bodies

The Parish Council enjoys membership to a number of external bodies to which nominated Councillors attend as elected representatives in order to represent the views of their communities as follows:

#### Greater Aylesbury Local Area Forum

Marcus Rogers acts are the representative for Stoke Mandeville Parish Council which includes the parishes of Bierton, Buckingham Park, Coldharbour, Watermead, Weedon and Aylesbury Town Council as well as Aylesbury Vale District Council, Bucks County Council, Buckinghamshire & Milton Keynes Fire Authority, Thames Valley Police and the voluntary sector. Meetings are held three times a year and allow a wide debate from around the area of the Forum. Members of the public are welcome to attend, to petition for services and ask questions. The Forum also has an allocated budget for improvements to the community and to take account of bids from voluntary groups and organisations in the area.

#### • Wendover Local Area Forum

Jenny Hunt represents the Parish Council on the Wendover Local Area Forum which has the same remit as that of the Great Aylesbury Local Forum outlined above but includes the Parishes of Aston Clinton, Buckland, Drayton Beauchamp, Halton and Weston Turville as well as Aylesbury Vale District Council, Bucks County Council, Buckinghamshire & Milton Keynes Fire Authority, Thames Valley Police and RAF Halton.

### Stoke Mandeville and Other Parishes Charity

Barbara Ezra is nominated by the Parish Council to serve on the Board of the Stoke Mandeville and Other Parishes Charity and is also the elected Chairman. The Board of Trustees are nominated by the Parish Councils of Stoke Mandeville, Prestwood and Great Hampden, which are partners within the Charity.

#### ARLA Liaison Group

Pat Wood is the Parish Council's representative on the liaison group, which serves to benefit local communities.

- Neighbourhood Plan Grant £2,800


Total Expenditure for the year was £105,589, the highest expenditure items were:

- Street lighting upgrade of some lamps to LEDs
- Employment of clerk
- Grass cutting
- Street lights electricity and maintenance
- Grounds maintenance around the parish

The under spend from 2017-18 is largely earmarked for the provision of a new burial ground for the parish, as well as improvement/security works to the Community Centre, Neighbourhood Plan and Parish Council election costs.

### How Stoke Mandeville Parish Council spent your Council Tax

The work of Parish Councils is funded by the precept which is collected by district councils through the Council Tax levy. For 2017-18 Stoke Mandeville Parish Council's precept represented a charge to an average Band D household of £55.37 per annum.



### Stoke Mandeville & Other Parishes Charity Grant.

The Stoke Mandeville and Other Parishes Charity provides a grant to the Parish Council which helps to keep the precept below the national average and also ensures that all residents benefit from the Charity. In 2018-19, the Parish Council have applied for a grant of £15,000.

### 2018-19 Precept

For the next financial year starting on 1 April 2018, the precept of the Parish Council will increase by just 7p per week for a property falling into council tax band 'D' and will vary from that upwards or downwards according to which council tax band your property falls within. The increase is necessary to deal with a number of high cost projects which have to be completed over the next three to five years as listed below:

- continued project to upgrade the street lights for which we are responsible to in accord with current requirements
- completion of a Neighbourhood Plan to help to manage the future growth and development of our Parish
- continued delivery of services devolved from Bucks CC with reducing subsidy
- development of a future burial ground for the Parish
